This is to inform you of a product recall involving: **ITEM #10004302, Genuine Maryland-Style Premium Crab Cakes**. A copy of the label is attached for ease of identification.

This voluntary recall has been initiated because it has the potential to contain undeclared hydrolyzed soy protein. People who have a soy allergy or severe sensitivity to soy may run the risk of serious or life-threatening allergic reaction if they consume this product.

We shipped 1287, 9lb bulk cases to you between 12/23/2019 and 07/21/2020 to you. Please immediately examine your inventory and quarantine any product subject to recall. In addition, if you may have further distributed this product, please identify your customers and notify them at once of this product recall.

TEMPER CAKES TO SEMI-SOFT CONSISTENCY IN REFRIGERATOR PRIOR TO COOKING.
DEEP FRY: Deep fry cakes at 350°F for about 3 minutes.
CONVENTIONAL OVEN: Par fry cakes for 30 - 45 seconds at 350°F then bake at 375°F for 7 - 8 minutes or until golden brown.
CONVECTION OVEN: Par fry cakes for 30 - 45 seconds at 350°F then bake at 350°F for 6 - 7 minutes or until golden brown.
BROIL: On HIGH HEAT with rack at center oven position, broil cakes for about 3 minutes, turn, baste with mayonnaise and broil for about 3 more minutes.
NOTE: COOK TO AN INTERNAL TEMPERATURE OF 155°F MINIMUM.
