#### Job Overview:

The Facility Maintenance Technician, reporting to the Facility Supervisor, plays a pivotal role in maintaining the facility's cleanliness and ensuring smooth operations. This position encompasses a wide range of maintenance and janitorial responsibilities. The Facility Maintenance Technician performs skilled and semi-skilled functions, including but not limited to carpentry, painting and minor electrical repair.

#### **Essential Functions:**

- 1. Maintain the facility's cleanliness according to a predetermined schedule.
- 2. Assists the Maintenance Mechanic with corrective, preventive, and emergency maintenance tasks.
- 3. Performs facility repairs, including carpentry, painting, minor electrical repair, and wall/floor repairs.
- 4. Performs routine warehouse floor maintenance, including sweeping, mopping, and operating powered floor scrubbers/sweeper.
- 5. Empties and cleans all waste and recycling containers, ensuring proper disposal.
- 6. Executes scheduled preventive maintenance (PM) tasks to uphold equipment functionality.
- 7. Identifies and reports building and equipment repair needs.
- 8. Adheres to safety, product handling, and security guidelines, and participates in daily stretching exercises.
- 9. Follows documented Food Safety/HACCP standard operating procedures.
- 10. Ensures timely completion of checklists and required records.
- 11. Maintains cleanliness and organization of storage areas for maintenance equipment, supplies, and tools.

## Additional Responsibilities:

- 1. Addresses immediate cleaning issues, such as spills and safety concerns.
- 2. Manages inventory of maintenance, operational, and janitorial supplies.
- 3. Performs Day Warehouse Associate tasks as needed.
- 4. Supports the picking and product loading functions for Will Call customers.
- 5. Assists in cleaning storage bins, plastic pallets, warehouse floors, walls, and doors.
- 6. Supports setup and cleaning after food cuttings and special events.
- 7. Clears snow from sidewalks and applies salt to necessary surfaces.
- 8. Assists in cleaning the exterior of the facility and grounds.
- 9. Aids the Facility Attendant in performing cleaning and janitorial duties.
- 10. Completes ongoing training requirements satisfactorily.
- 11. Fulfills other duties as required or assigned.

### Knowledge, Skills, and Abilities:

- 1. Ability to perform basic mechanical, electrical, carpentry, and plumbing installations and repairs.
- 2. Demonstrate sound judgment and maturity in handling unexpected issues.
- 3. Follow written and verbal instructions effectively.
- 4. Ability to obtain OSHA certification for operating warehouse rolling stock.
- 5. Possess basic computer knowledge (highly desirable).
- 6. Understand and interpret utility and system drawings.
- 7. Maintain a customer service-oriented, team-focused attitude.
- 8. Operate all necessary cleaning equipment proficiently.
- 9. Exhibit strong organizational abilities, follow-up skills, and attention to detail in work and communication.
- 10. Address team concerns and maintenance needs professionally and courteously.
- 11. Possess strong English language skills, both verbally and in writing.
- 12. Work independently with minimal supervision.
- 13. Ability to effectively prioritize assigned work.
- 14. Be punctual and dependable.
- 15. Demonstrate courtesy and tact.

#### **Education/Experience (Preferred Minimum Qualifications):**

Possession of a high school diploma or Graduation Equivalency Degree (GED),

#### AND

A minimum of one (1) year of experience with semi-skilled and skilled tasks, such as basic mechanical, electrical, carpentry, and plumbing installations and repairs.

## Licenses/Certifications/Special Requirements:

- 1. Must pass a pre-employment drug test.
- 2. Subject to random and reasonable suspicion drug testing.
- 3. Subject to a pre-employment background check.
- 4. Experience in using a Computerized Maintenance Management System (CMMS) preferred.
- 5. Ability to be trained in and operate according to the documented lockout-tagout program.
- 6. Required to wear approved composite or steel-toe, slip-resistant work boots or shoes.
